#### **EdChoice Legislation Update**

The EdChoice Scholarship program provides Ohio students from designated public schools the opportunity to attend private schools based on a voucher system. Ed Choice changes on what seems to be a daily basis. Bill Wade stated, "Ed Choice is a hot mess." The House is trying to pass a Senate Bill which would get rid of performance based vouchers and go to vouchers being entirely income based. They are trying to make this voucher program State funded. The Senate voted this plan down. The House & Senate need to finish negotiating and find a compromise by April 1, 2020. Tim Cosgrove is confident they will come together at the State level to find a solution.

Impact Ed Choice could have on us (if it doesn't change), Elementary S's get \$4650 for vouchers each year from local district, our school district only gets approximately \$800 per student from the State, so we will be paying approximately \$3,850 per EdChoice student grades K-8. High School Ed Choice S's would get \$6,000 a year, with approximately \$800 per S from State, so approximately \$5200. KES was the only school identified as a low performing school, per the recently expanded EdChoice legislation passed summer of 2019, HB 166. KES was placed on the list b/c it received an F in Value Added on the State Report card. The State has since publicly recognized the inaccuracies of the report card scores overall and are looking at a means to rectify this.
