ISSUE 1: WILL NOT BAISE TAXES

What is Issue 1?

Issue 1 is a 7.07-mill, five-year renewal operating levy on the May 2 ballot. Issue 1 will continue to generate \$2.28 million annually for general operating expenses - about 16 percent of the Kirtland Local Schools' total budget. Issue 1 will allow the district to maintain its current level of academic excellence without raising taxes.

What will dollars fund?

Operating levy dollars are used for the following expenses:

- Direct classroom instruction •
- Student services (nurses, counselors, media specialists)
- Diverse and well-rounded extracurricular programs
- Safety and security
- K-12 transportation •
- Daily operating expenses •

What has the district done to operate more efficiently?

The Kirtland Local Schools and the Board of Education take fiscal responsibility to the community seriously. Since this levy was first approved in 2012, annual expense growth averages 1.55 percent, compared to

Our district takes its fiscal responsibility to the community seriously. Following the Board's fiscal management beliefs, the district has held its annual expense growth to an average of 1.55 percent – half of the state average. We also look for ways to cut expenses, including sharing services and looking for alternative funding opportunities.

Issue 1 will allow the Kirtland Local Schools to maintain educational excellence into the future. 

DISTRICT MONITORING STATE BUDGET RECOMMENDATIONS

This spring, the Ohio Legislature is developing a state budget that includes a proposed reduction of \$294,000 over two years. Although our Board of Education actively oversees prudent management of expenses and aggressively pursues avoidance of deficit spending, the district does not control local and state sources of funding. Those two primary income areas have a significant impact on fiscal management. The State of Ohio's school funding model places the primary responsibility for funding primary and secondary education on local communities. The Kirtland Local Schools receive 91 percent of its funding from local sources, 6 percent from the state, and 3 percent from miscellaneous income, such as investment income, fees and other sources. 
KMS STUDENT "TAKING A STAND" AT NATIONAL **HISTORY DAY STATE CONTEST**

Michael made it to the regional spelling bee after lasting through 26 rounds, 93 words and beating out a series of students to emerge as the 2017 Lake County Spelling Bee Champion in February. Aside from being an accomplished speller, Michael also plays the piano and plays in several sports, including baseball, soccer and basketball.





Service is a mainstay for the Kirtland High School Key Club. Key Club is the oldest and largest service program for high school students. The studentled organization teaches leadership through service to others.

At KHS, 95 Key Club members have been working throughout the school year on a variety of service projects that impact the greater community-at-large:

- In the fall, Key Club collected and shipped more than 150 pounds of candy for Operation Gratitude, an organization that collects candy around Halloween to send in care packages to troops overseas.
- In December, Key Club collected food donations for the Kirtland Area Service Council. Twenty-two student volunteers organized and delivered the baskets of food to members of the community in need.

• In March, Key Club worked with the Kirtland Middle School Builders Club and adviser Greg Bell to collect donations for the Homeless Veterans Outreach Program at the VA. The program collects hygiene and household items used to make starter packs for veterans in need.

Adviser Allison Eckerle says Key Club holds monthly meetings, participates in the Homecoming parade, and provides assistance with Kirtland Candidates' Night. Students also attend weekly Kiwanis meetings.



WKES/THE KIRTLAND BUZZ PREMIERES AT KES

Kirtland Elementary School launched a weekly video announcement, turning fifth-grade students into a news crew for WKES (The Kirtland Buzz).

Teacher Bob Lasecki received a camera, a green screen and an editing program from the high school and Technology Department, paving the way for the new endeavor. The first broadcast involved studentcreated Google Slides. That attracted interest from more students interested in being part of the crew.

"I challenged groups of fifth graders to come up with a script using Google Slides," Lasecki said. "Each week I get a few crews interested. I also challenge them to come up with new commercials and segments, like Principal's Perspective, Tech Talk and Superintendent Talk. It has become a great thing for them to do in computer class and outside of school."

Lasecki handles the editing, but the rest is all students. He taught them how to use the camera, along with speaking and interviewing skills.

"The production skills that they learn are awesome," Lasecki said. "A great memory for the kids, and skills that they will use later in life."
