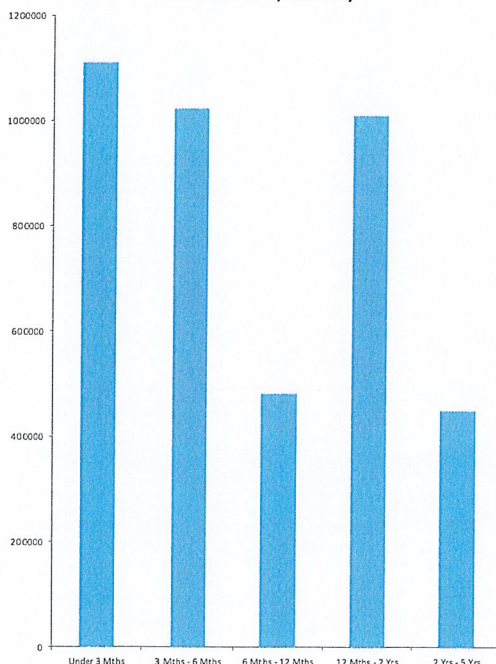

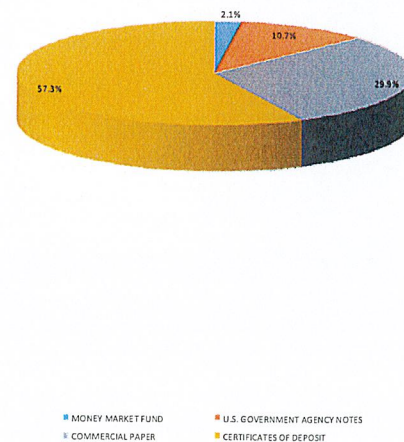

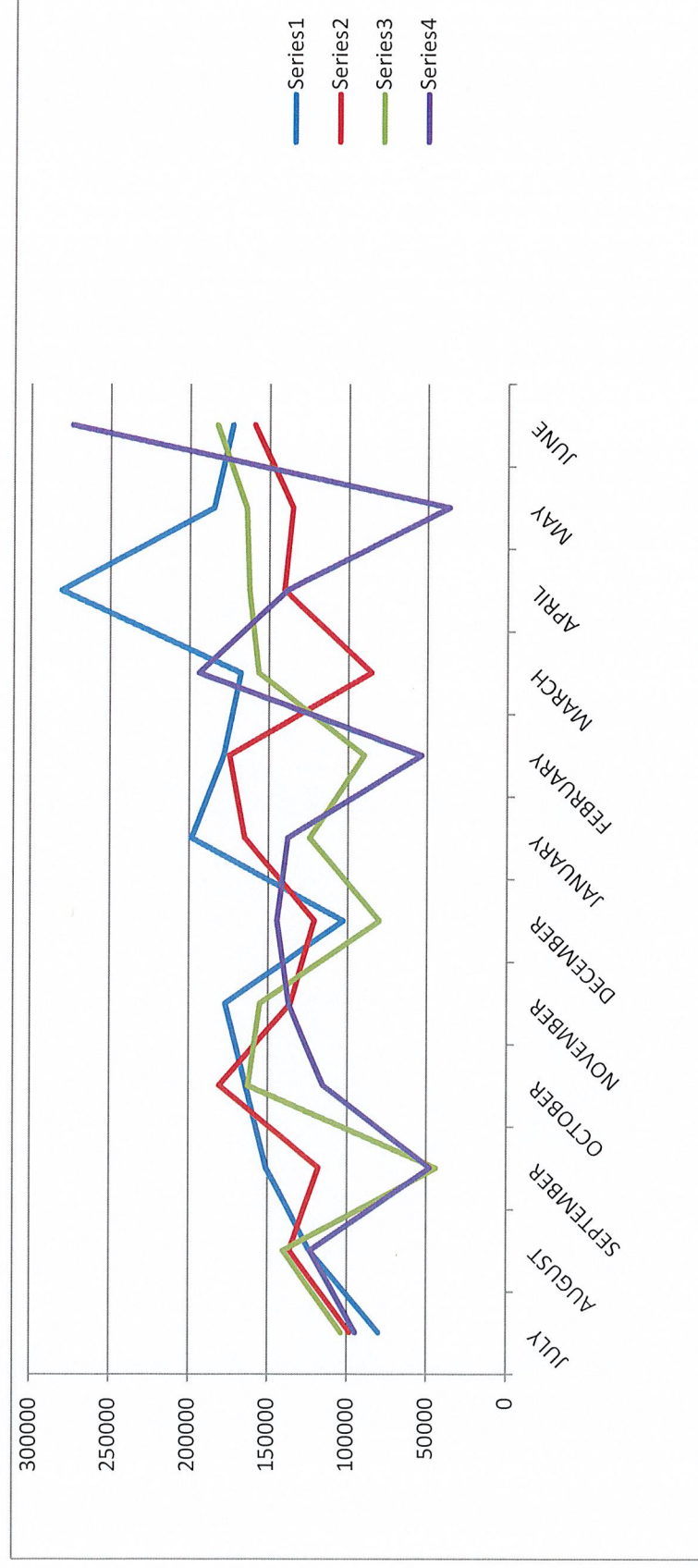
FY2023 Revenue Comparison
