#### **ELA UPDATES**

- A. Katy Nagaj discussed the ELA curriculum audit process @KES. ELA committee set goals using building wide consistency, adoption of Heggerty K-2 & increased rigor in writing instruction w/ emphasis on conventions and grammar.
  - \* Training for teachers via ESC instructors & professional development work.
  - \* AimsWeb data analysis, Heggerty PD, Science of Reading updates & writing instruction.
- B. Scott Amstutz discussed the ELA curriculum audit process @KMS/KHS.

  Initially started the process in 2019, Covid slowed everything down.

  ELA Committee/Curriculum Coaches meet monthly.

- \*Professional development training for teachers (science of reading, standard review & resource audit); continued work for T's on PLC (Prof Learning Committees) & delayed starts.
- \* Continue to look at the local data, review state test data & support benchmark assessments.
- \*Writing instruction-cont. conversation of the process of writing.
- C. Chad VanArnhem & team discussed -Curricular Adoption timeline and structure
  - i. Spring 2022: K-8 explore materials and decide on two programs
  - ii. Fall 2022: K-8 pilot two sets of curricular materials/9-12. Explore these materials and decide on a program to pilot (only one).
  - iii. Winter 2023: K-8 adopt and implement materials/9-12 pilot
  - iv. Spring 2023: 9-12 adopt materials to implement Fall 2023
  - v. T's in 6-12 started looking at materials to provide feedback
  - vi. We will be using Edreports Adoption Rubrics (Edreports.org)

  - vii. K-2 Evidence and ELA 3-8 Evidence. Looking @ 3 gateways: text quality and complexity, building knowledge and usability
